### PUBLIC NOTICE

**Petition presented pursuant to Appendix B of *By-law concerning the Montreal Charter of Rights and Responsibilities and on the right of initiative (05-056)***

#### **DEVELOPMENT OF DEAUVILLE PARK Beginning of petition signing period (90 days)**

PUBLIC NOTICE is given of the following:

A draft petition to request a public consultation on the development of Deauville Park with the purpose:

Demolition and destruction of the majority of the green spaces of Deauville Park, to install huge cement surfaces and the construction of a future amphitheater that will double the capacity of the park. This was done without democratic consultation of the citizens of the area affected by the work.

We request:

- 1- To add shrubs/cedars, minimum 3-4 feet high (as an example some parks on the territory of Pierrefonds: Duval park, Coursol park with fences, at Cap St-Jacques and others) all along rue De Fontenay, to replace the loss of green spaces.
- 2- Make the main entrance to the park through the parking lot only.

was deposited at the secretariat of the Borough of Pierrefonds-Roxboro on October 13, 2022, in accordance with the right of initiative provided for in By-law 05-056 concerning the Montréal Charter of Rights and Responsibilities and the right of initiative (hereinafter referred to as the "By-law").

A response confirming the admissibility of the draft petition was sent on October 21, 2022 to the representatives of the group that filed the draft petition. A copy of this reply was then tabled at the regular sitting of the Borough Council held on November 7, 2022.

#### ***Beginning and duration of the petition signing period***

In accordance with Section 10 of Schedule B of the Regulations, the petition period is 90 days. It begins on the date of publication of this notice and ends on **March 21, 2023**.

#### ***Number of signatures required***

The number of signatures required for the petition to be valid is **2903** signatures.

***Required quality of signatories***

Is a person eligible to sign a petition, any person aged 15 years and over living on the territory of the Borough of Pierrefonds-Roxboro.

***How to sign the petition***

The standardized electronic petition form provided by the City shall be used for the purpose of exercising the right of initiative. No other form of petition will be received.

This form must be completed and submitted according to the specifications indicated.

Every person who signs a petition for the purpose of exercising the right of initiative shall, in the place and manner provided for that purpose, solemnly declare that he or she meets the criteria of a qualified signer.

Electronic signatures are accepted on the City's standardized electronic form for the purpose of exercising the right of initiative.
