### By-law for a mixed metropolis

#### Public consultation: Updating the by-law and creating new affordable housing zones

At its meeting on November 20, 2023, city council adopted

- draft by-law P-20-041-9 titled "Règlement modifiant le Règlement visant à améliorer l'offre en matière de logement social, abordable et familial (20-041)"
- draft by-law P-20-041-10 titled "Règlement modifiant le Règlement visant à améliorer l'offre en matière de logement social, abordable et familial (20-041)"

Draft by-law P-20-041-9 aims to amend schedule B of by-law 20-041 concerning the improvement of the supply of social, affordable and family housing for purposes of adding new affordable housing zones in Ville-Marie, Rosemont–La Petite-Patrie, Anjou and Le Sud-Ouest boroughs.

Draft by-law P-20-041-10 aims to update the parameters of the by-law based on property values, to revise certain definitions and certain technical aspects, and to introduce temporary measures.

In accordance with the Act respecting land use planning and development (CQLR, c. A-19.1), a public consultation will be held to discuss these draft by-laws.
