



## COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of December 18, 2023:

- 23-042 Règlement sur les taxes (exercice financier 2024)**  
This by-law concerns taxes for fiscal 2024.
- 23-043 Règlement concernant la taxe foncière sur les parcs de stationnement (exercice financier 2024)**  
This by-law concerns property tax on parking lots for fiscal 2024.
- 23-044 Règlement sur les tarifs (exercice financier 2024)**  
This by-law concerns fees for fiscal 2024.
- 23-045 Règlement relatif à la tarification de l'eau fournie aux immeubles non résidentiels (exercice financier 2024)**  
This by-law concerns tariffing of water supplied to non-residential buildings for fiscal 2024.
- 23-046 Règlement sur les émissions de gaz à effet de serre des nouveaux bâtiments**  
This by-law concerns greenhouse gas emissions from new buildings.
- 21-012-1 Règlement modifiant le Règlement sur l'encadrement des animaux domestiques (21-012)**  
This by-law amends by-law 21-012 concerning domestic animals, facilitating the application of the by-law by adjusting or correcting some elements, especially the ones related to permits, at risk, potentially dangerous or prohibited dogs and the disposal of an animal's body.
- 23-047 Règlement visant à assurer la mise en place et la fonctionnalité des voies de circulation réservées à l'usage exclusif des bicyclettes et de certaines catégories de véhicules**  
This by-law aims to ensure the implementation and functionality of traffic lanes reserved for the exclusive use of bicycles and certain categories of vehicles.

- 02-002-43 Règlement modifiant le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissements (02-002)**  
This by-law amends by-law 02-002 concerning the delegation of city council powers to borough councils by delegating the power to award contracts for the acquisition of goods and general services that may be awarded by mutual agreement in accordance with the city council by-law 18-038 on contract management, i.e. those whose expenditure is between \$25,000 and the public tendering threshold.
- 20-041-9 Règlement modifiant le Règlement visant à améliorer l'offre en matière de logement social, abordable et familial (20-041)**  
This by-law amends schedule B of by-law 20-041 concerning improving the supply of social, affordable and family housing by adding nineteen areas of affordable housing in Ville-Marie, Rosemont-La Petite-Patrie, Anjou and Sud-Ouest boroughs.

All these by-laws come into force December 22 2023. However, article 17 of by-law 21-012-1 amending article 55 of by-law 21-012 comes into force on the date determined by the executive committee.
