

ORDINANCES

Notice is given that the following ordinances were adopted at the executive committee meeting of June 12, 2024:

Ordonnance remplaçant le formulaire de demande de permis (1)

This ordinance, adopted under article 34 of by-law 21-041 concerning pesticide sales and use, replaces the permit application form in schedule 4 to the by-law.

Ordonnance relative au stationnement tarifé : stationnement sur rue de type parcojour – nouveaux secteurs (5)

This ordinance, adopted under article 124 of by-law 23-044 concerning fees (fiscal 2024), amends article 119 of the by-law to add Parcojour-type on-street parking fees, applicable as of June 17, 2024, for the « St-Patrick-Nordelec », « Parc Angrignon » and « Hôpital Jean-Talon » areas. Schedule 8 to the by-law is also replaced.

Ordonnance émise dans le cadre de la Semaine québécoise des familles – Accès gratuit au Jardin Botanique, au Biodôme, au Planétarium ou à l’Insectarium (6)

Ordonnance adoptée dans le cadre du Festival Astrofest – Accès au Planétarium (7)

The above two ordinances were adopted under article 128 of by-law 23-044 concerning fees (fiscal 2024). Ordinance 6, adopted as part of Québec Family Week, grants free admission to holders of a pass issued by the city, valid for one visit per family, to one of the following institutions: the Jardin botanique, from July 1 to August 30, 2024, the Biodôme, from July 1 to December 20, 2024, the Insectarium or Planetarium, from September 3 to December 20, 2024. Ordinance 7, adopted as part of the Astrofest festival, grants free admission to conferences to be held at the Planétarium on June 15, 2024, as of 5 pm and on June 16, from 10 a.m. to 11 a.m.

Ordonnance émise dans le cadre de la Semaine québécoise des familles – Accès gratuit à la Biosphère (4)

This ordinance was adopted under article 92 of by-law RCG 23-028 concerning urban agglomeration fees (fiscal 2024) as part of Québec Family Week to provide free admission to the Biosphère for holders of a pass issued by the city, valid for one visit per family, from July 1 to December 20, 2024.

Ordonnance fixant la date d’entrée en vigueur du Règlement modifiant le Règlement sur les services (22-017-1) (1)

This ordinance, adopted under article 2 of by-law 22-017-1 amending the by-law concerning city departments, provides that by-law 22-017-1 comes into force on June 15, 2024.

All these ordinances come into force on June 14, 2024, and are available for consultation (French version only) during regular office hours at the Service du greffe, 275, rue Notre-Dame Est, as well as online at montreal.ca/reglements-municipaux/.
