### PUBLIC CONSULTATION MEETING

**Proposed amendment to the "Schéma d'aménagement et de développement de l'agglomération de Montréal" (land use planning and development concept) to take the "Plan régional des milieux humides et hydriques" (regional wetlands and water management plan) into account, as well as protection measures for wetlands**

On March 21, 2024, Montréal adopted a [regional wetlands and water management plan, the "Plan régional des milieux humides et hydriques" \(in French\)](#), under the *Act to affirm the collective nature of water resources and to promote better governance of water and associated environments*.

At its meeting on March 21, 2024, the agglomeration council adopted, through resolution CG24 0164, a draft by-law to amend the Schéma so as to ensure its compatibility with the "Plan régional des milieux humides et hydriques" and provide for consistency in land-use decision-making. This draft by-law proposes to:

- Take the "Plan régional des milieux humides et hydriques" and the "Nature and Sports Plan" into account within the content of the Schéma;
- Identify wetlands of interest to be protected or restored;
- Integrate specific objectives for the protection of wetlands of interest, particularly in agricultural zones;
- Integrate the provisions necessary for the preservation of wetlands of interest into the complementary document;
- Make administrative adjustments consistent with the above-mentioned amendments;
- Remove provisions arising from the *Protection Policy for Lakeshores, Riverbanks, Littoral Zones and Floodplains*.

#### **Summary of the main effects of the proposed amendments to the Schéma on targeted areas:**

Urban planning by-laws for Baie-d'Urfé, Beaconsfield, Côte-Saint-Luc, Dollard-des-Ormeaux, Dorval, Kirkland, L'Île-Dorval, Montréal-Est, Pointe-Claire, Sainte-Anne-de-Bellevue, Senneville as well as Montréal's Ahuntsic-Cartierville, Anjou, Côte-des-Neiges–Notre-Dame-de-Grâce, L'Île-Bizard–Sainte-Geneviève, Lachine, LaSalle, Le Sud-Ouest, Mercier–Hochelaga-Maisonneuve, Pierrefonds-Roxboro, Rivière-des-Prairies–Pointe-aux-Trembles, Saint-Laurent, Saint-Léonard, Verdun, Ville-Marie and Villeray–St-Michel–Parc-Extension boroughs must be amended to introduce:

- Wetlands and their protected areas;
- Definitions;
- Requirements for characterization studies;
- Regulatory sections resulting from the addition of Provisions 4.4.4.1 to 4.4.4.4 (4.4.4 - Provisions relating to wetlands of interest to be protected or restored and their protection area) and the amendment made to Provision 4.4.3 - Prohibition of certain invasive species of the Schéma's complementary document.

#### **Public consultation meeting**

In accordance with section 53 of the *Act respecting land use planning and development*, the Commission sur le schéma d'aménagement et de développement de Montréal consults the population of the Montréal agglomeration when an amendment to the Schéma is requested.

The purpose of the public consultation meeting is to inform the population and inform the decision-making of the elected members of the agglomeration council.
