

COMING INTO FORCE OF BY-LAWS

Notice is given that the following by-laws were adopted at the city council meeting of December 16, 2024:

- 24-042** **Règlement sur les taxes (exercice financier 2025)**
This by-law concerns taxes for fiscal 2025.
- 24-043** **Règlement concernant la taxe foncière sur les parcs de stationnement (exercice financier 2025)**
This by-law concerns property tax on parking lots for fiscal 2025.
- 24-044** **Règlement sur les tarifs (exercice financier 2025)**
This by-law concerns fees for fiscal 2025.
- 24-045** **Règlement relatif à la tarification de l'eau fournie aux immeubles non résidentiels (exercice financier 2025)**
This by-law concerns tariffing of water supplied to non-residential buildings for fiscal 2025.
- 18-020-4** **Règlement modifiant le Règlement fixant le montant des amendes à l'égard des infractions en matière de stationnement ou d'immobilisation des véhicules (18-020)**
The by-law amends by-law 18-020 concerning vehicle parking or immobilization fines. The purpose of the amendments is to increase the amount of the fines set out in the by-law.
- 24-049** **Règlement établissant le programme de soutien financier visant la consolidation des sociétés de développement commercial et l'amélioration des affaires pour les années 2025 à 2027**
The by-law establishes the financial support program for the consolidation of commercial development associations and business improvement for the years 2025 to 2027.
- 02-002-45** **Règlement modifiant le Règlement intérieur de la Ville sur la délégation de pouvoirs du conseil de la ville aux conseils d'arrondissement (02-002)**
This by-law amends by-law 02-002 concerning the delegation of city council powers to borough councils by delegating the power to adopt by-laws pertaining to the parking of any vehicle on land without prior authorization from the owner or occupant of that land.
- 08-055-10** **Règlement modifiant le Règlement du conseil de la ville sur la délégation de certains pouvoirs relatifs au réseau de voirie artérielle aux conseils d'arrondissement (08-055)**

This by-law amends by-law 08-055 concerning the delegation to borough councils of certain powers relating to the arterial road system. Amendments pertain to article 2 of the by-law concerning the delegation to borough councils of certain powers regarding snow disposal sites.

All these by-laws come into force December 20, 2024, except for by-law 18-020-4 which will come into force January 20, 2025. They may be consulted (French version only) during regular business hours at the Service du greffe, 275, rue Notre-Dame Est and are also available at montreal.ca/reglements-municipaux/.
