

ORDINANCES

Notice is given that the following ordinances were adopted at the executive committee meeting of August 20, 2025:

Ordonnance relative à l'autorisation de la garde d'animaux de ferme dans le cadre de la Fête des récoltes tenue le samedi 11 octobre 2025 sur le territoire de l'arrondissement de Lachine (13)

This ordinance, adopted under by-law 21-012 concerning domestic animals, authorizes the keeping of farm animals as part of the harvest festivities to be held on October 11, 2025, in Lachine borough.

Ordonnance visant à remplacer l'annexe A et fixer la date de l'entrée en vigueur du chapitre III du Règlement sur l'occupation et l'entretien des bâtiments (23-016) pour la mise en place de l'enregistrement des bâtiments vacants (1)

This ordinance, adopted under by-law 23-016 concerning building occupancy and maintenance, replaces schedule A to the by-law and determines that chapter III of the by-law, pertaining to the registration of vacant buildings, comes into force on January 1, 2026.

Ordonnance modifiant l'annexe A du Règlement sur la subvention à la réalisation de logements coopératifs et à but non lucratif (AccèsLogis Montréal) (02-102) (19)

Ordonnance approuvant des modifications aux conventions d'exploitation types existantes aux fins de l'application du règlement (20)

The above ordinances (19 and 20) are adopted under by-law 02-102 concerning subsidies for the development of non-profit cooperative housing (AccèsLogis Montréal program). Ordinance 19 amends schedule A to the by-law by increasing the median rents thereunder. Ordinance 20 approves amendments to existing standard operating agreements for the purposes of the by-law.

Ordonnance modifiant les loyers abordables prévus à l'annexe A (6)

This ordinance, adopted under by-law 20-005 concerning the support program for the renovations of multi-rental buildings, replaces affordable rents set out in tables 1 and 2 of schedule A to the by-law.

Ordonnance visant à augmenter le montant total de l'aide financière prévue au programme (2)

This ordinance, adopted under by-law RCG 21-019 concerning subsidies for the acquisition of immovables by social economy enterprises, and the construction and renovation of buildings designated for economic activities with a social purpose, increases the total value of the financial assistance under the program to \$12,550,000.

Ordonnance édictée relativement aux tarifs du service BIXI (13)

This ordinance, adopted under by-law 24-044 concerning fees (fiscal 2025), incorporates new fees for the use of BIXI trailers.
