BY-LAW REPEALING BY-LAW CA29 0059 CONCERNING THE TRAFFIC AND RESTRICTION OF HEAVY VEHICLES LOADS ON THE BRIDGE OF BOULEVARD PITFIELD, NORTH DIRECTION IN THE BOROUGH OF PIERREFONDS-ROXBORO

WHEREAS section 66 of the Municipal Powers Act (R.S.Q., c. C-47.1);

WHEREAS section 105 of the Charter of the Ville de Montréal (R.S.Q., c. C-11.4);

WHEREAS the by-law of the City Council on the delegation of certain powers relating to the arterial road network to Borough Councils (08 055);

WHEREAS structural reinforcement work on the Pitfield Bridge was carried out during the summer of 2025 and vehicle load restriction is no longer necessary;

THE BOROUGH COUNCIL ENACTS THE FOLLOWING:

ARTICLE 1. The following by-law is repealed:

By-law CA29 0059 concerning the traffic and restriction of heavy vehicles loads on the bridge of boulevard Pitfield, north direction in the Borough of Pierrefonds-Roxboro

ARTICLE 2. This by-law comes into force in accordance with the Law.
