Please note that the FINAL agenda is the one adopted by the municipal councillors at the beginning of each meeting.

The meeting will be preceded by a public consultation meeting, at 6 p.m., concerning the following proposal:

- Draft by-law RCA08 17146 amending the *Urban Planning By-law of the Côte-des-Neiges—Notre-Dame-de-Grâce borough* (01-276) to control non-residential uses along rue Saint-Jacques, between the extension of avenue Madison and the Décarie expressway, so as to ensure greater compatibility between uses and the residential character of the sector, pending the implementation of the detailed planning study on Saint-Jacques/Upper Lachine.
- Draft by-law RCA08 17148 amending the *Urban Planning By-law of the Côte-des-Neiges—Notre-Dame-de-Grâce borough* (01-276) to authorize specific uses in commercial category C.2 at a level immediately above the ground floor, in the avenue Victoria area, and amend the boundaries of this use sector.
- Draft by-law RCA08 17150 amending the *Urban Planning By-law of the Côte-des-Neiges—Notre-Dame-de-Grâce borough* (01-276), so as to introduce infill construction rules for building coverage ratios in sectors H.1 to H.3.
