**NOTICE** is also given to undivided co-owners of an immovable and cooccupants of a business establishment who are not already entitled to be entered on the list of electors of Montréal as domiciled persons, as sole owners of an immovable, or as sole occupants of a business establishment, that they must meet the following conditions to be entered on the list of electors for the by-election scheduled for December 14, 2008:

- 1. be 18 years old or more on December 14, 2008
- 2. be a natural person, a Canadian citizen, and neither be, on **October 30, 2008**, under curatorship nor, at this date, under any conviction, in the last 5 years, for an offence constituting a corrupt electoral practice

- since at least October 30, 2007, have been the undivided co-owner of an immovable or the co-occupant of a business establishment in Cecil-P.-Newman electoral district, in LaSalle borough
- have been designated under a power of attorney signed by the majority of coowners or co-occupants who are qualified to vote on October 30, 2008
- have filed, with the returning officer, at the address shown below, the power of attorney no later than November 10, 2008, at 4 p.m.

PLEASE NOTE that an application for entry on the list of electors or for a power of attorney received after November 10, 2008, at 4 p.m., but no later than November 18, 2008, the last day of application to the board of revisors, will be considered as an application to amend the electoral list, and will therefore submitted to the board of revisors.

Applications for entry on the list of electors or for a power of attorney are available from the returning officer or on the Web site at the address shown below. All applications for entry on the list of electors and for powers of attorney take effect on receipt and remain valid until they are withdrawn or replaced.
