## **PUBLIC NOTICE OF REVISION OF THE LIST OF ELECTORS**

### **Cecil-P.-Newman electoral district LaSalle borough**

**NOTICE is given to electors of Cecil-P.-Newman electoral district, in LaSalle borough that:**

1. The list of electors was filed with the returning officer on **November 7, 2008**. It is subject to revision before being used for the by-election.
2. To qualify as an elector and qualify for entry on the list of electors, every person must:
  - be an individual
  - be 18 or over on **December 14, 2008**  
**and, on October 30, 2008**
  - be a Canadian citizen
  - not be under curatorship
  - not be disqualified under the law

**Every person must also meet one of the following conditions:**

- have been domiciled on the territory of Cecil-P.-Newman electoral district, in LaSalle borough, on **October 30, 2008**, and in Québec, since **at least April 30, 2008**, or
- have been the sole owner of an immovable on the territory of Cecil-P.-Newman electoral district, in LaSalle borough, since **at least October 30, 2007**, and have filed a written application for entry with the returning officer, or
- have been the sole occupant of a business establishment on the territory of Cecil-P.-Newman electoral district, in LaSalle borough, since **at least October 30, 2007**, and have filed a written application for entry with the returning officer.

Where an immovable belongs to undivided co-owners or where a business establishment is occupied by co-occupants, no person other than the undivided co-owner or the co-occupant designated under a power of attorney signed by the majority of co-owners or co-occupants may be entered on the list of electors as owner of the immovable or occupant of the business establishment. The power of attorney must be filed with the returning officer.

A person who is an elector in more than one capacity may be entered on the list of electors in only one capacity, in the following order of precedence:

- (1) as a domiciled person
- (2) as the sole owner of an immovable
- (3) as the sole occupant of a business establishment
- (4) as the undivided co-owner of an immovable
- (5) as the co-occupant of a business establishment

**No person may be entered at more than one place on the list of electors of Cecil-P.-Newman electoral district, in LaSalle borough.**

### **IMPORTANT**

Where an application for entry of a person domiciled on the territory of Cecil-P.-Newman electoral district, in LaSalle borough, is filed, the person who files the application with the board of revisors must specify the previous home address of the person concerned, and produce 2 documents: one confirming his name and date of birth, and the other, his name and present home address.

You may consult the list of electors and file applications for entry (**domiciled electors only**), correction or striking off with the board of revisors, at the time and place shown below:
