

PUBLIC NOTICE COMING INTO FORCE OF BY-LAWS

Notice is given that:

- The following by-law was adopted at the urban agglomeration council meeting of December 18, 2008:

RCG 08-053 **Règlement autorisant un emprunt de 5 000 000 \$ afin de financer diverses études détaillées relatives à la mise en place de la première ligne du réseau initial de tramways**
(By-law authorizing a loan of \$5 000 000 for various detailed studies on the development of the first line of the initial tramway system)

- The following by-laws were adopted at the city council meeting of December 15, 2008:

08-053 **Règlement autorisant un emprunt de 17 200 000 \$ pour l'aménagement d'une nouvelle cour de service principale dans l'arrondissement du Plateau Mont-Royal, et pour la relocalisation de la cour de la Commune dans l'arrondissement de Ville-Marie**
(By-law authorizing a loan of \$17 200 000 for the development of a new main service yard in Le Plateau-Mont-Royal borough, and the relocation of De la Commune yard in Ville-Marie borough)

08-058 **Règlement autorisant un emprunt de 15 000 000 \$ afin de financer la réalisation de travaux d'aménagement et de construction de pistes cyclables relevant de la compétence du conseil de la Ville**
(By-law authorizing a loan of \$15 000 000 for the development and construction of bike paths, under the authority of the city council)

08-059 **Règlement autorisant un emprunt de 30 000 000 \$ afin de financer les travaux de réfection, de reconstruction ainsi que le réaménagement de structures routières**
(By-law authorizing a loan of \$30 000 000 for the repair, rebuilding and redevelopment of road structures)

- 08-060** **Règlement autorisant un emprunt de 40 000 000 \$ afin de financer l'acquisition d'équipements et de services professionnels en informatique**
(By-law authorizing a loan of \$40 000 000 for the acquisition of computer equipment and for professional services)
- 08-061** **Règlement autorisant un emprunt de 50 000 000 \$ pour le financement des travaux de protection des immeubles**
(By-law authorizing a loan of \$50 000 000 for the protection of immovables)
- 08-062** **Règlement autorisant un emprunt de 15 000 000 \$ afin de financer l'acquisition d'équipements et de mobilier urbain**
(By-law authorizing a loan of \$15 000 000 for the acquisition of equipment and urban furniture)

By-laws RCG 08-053, 08-053, 08-058, 08-059 and 08-060, were approved by the Ministre des Affaires municipales, des Régions et de l'Occupation du territoire on January 13, 2009. By-laws 08-061 and 08-062, were approved on January 14, 2009.
