ORDINANCES

Notice is hereby given that the following ordinances were enacted by the Côte-des-Neiges—Notre-Dame-de-Grâce Borough Council at its regular meeting held on March 2, 2009.

BY-LAW CONCERNING NOISE (R.B.C.M., c. B-3, article 20)

Ordinance permitting the use of amplifiers outdoors on the sites and at the dates indicated in Table 1.

BY-LAW CONCERNING PEACE AND ORDER ON THE PUBLIC DOMAIN (R.B.C.M., c. P-1, articles 3 and 8)

Ordinance authorizing the sale of promotional products, food, alcoholic or non-alcoholic beverages and the consumption of such alcoholic beverages on the sites and at the dates indicated in Table 1.

BY-LAW CONCERNING TRAFFIC AND PARKING (R.B.C.M., c. C-4.1, article 3, paragraph 8)

Ordinance authorizing measures to slow traffic and street closures on the sites and at the dates indicated in Table 1.

BY-LAW ON EXEMPTIONS RESPECTING PARKING UNITS (5984 amended, article 3)

Ordinance exempting the owner of the land and the building to be built on lot 2 087 318, on the west side of boulevard Décarie, north of chemin de la Côte-Saint-Luc, from the obligation to provide ten of the fourteen parking spaces required.
